The trust registered under Indian Trust Act 1882 and registration number 500 in 2014-15. The establishment of the organization was, momentous, as the district then was in the middle of Economic crisis, with the closure of many NBFCs (Non-Banking Financial Companies). In the district famous for the prices of areca nut the main

B. Growth and Development of Shri Saraswathi Credit Souharda Sahakari Limited

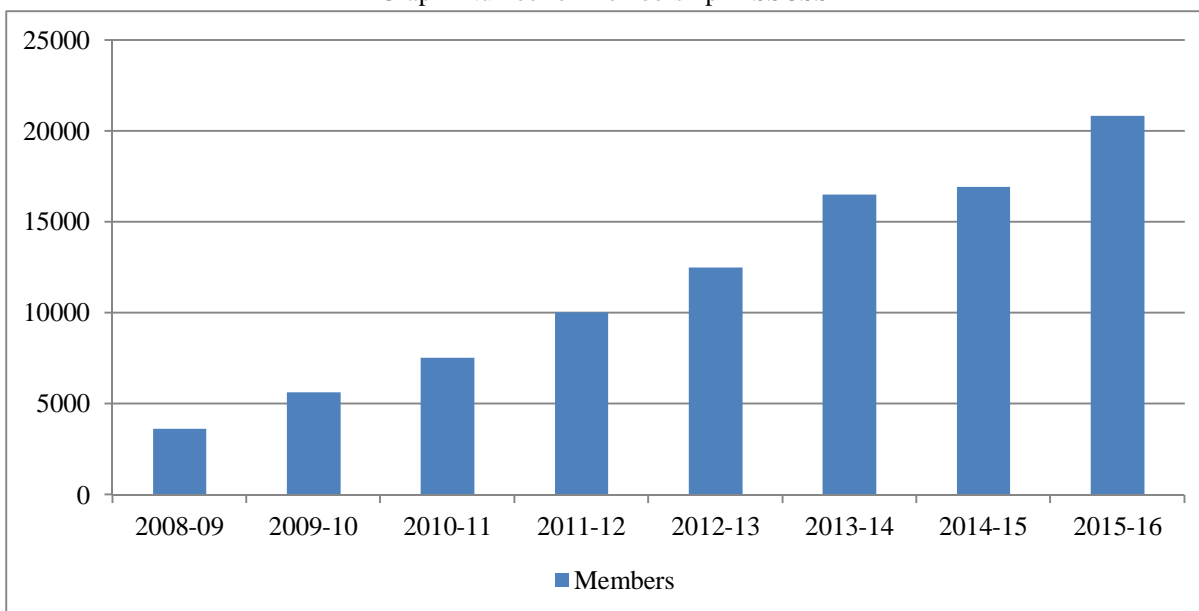

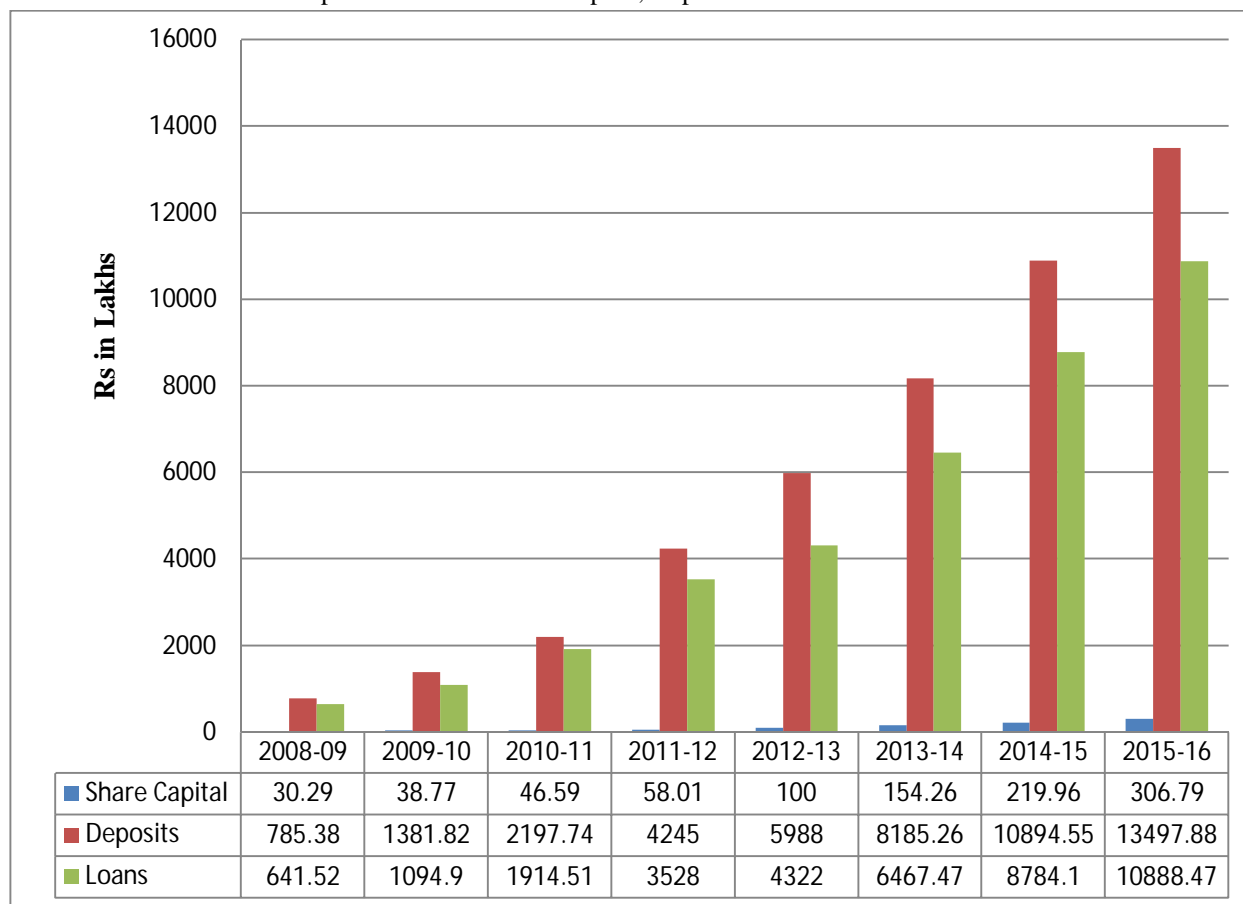

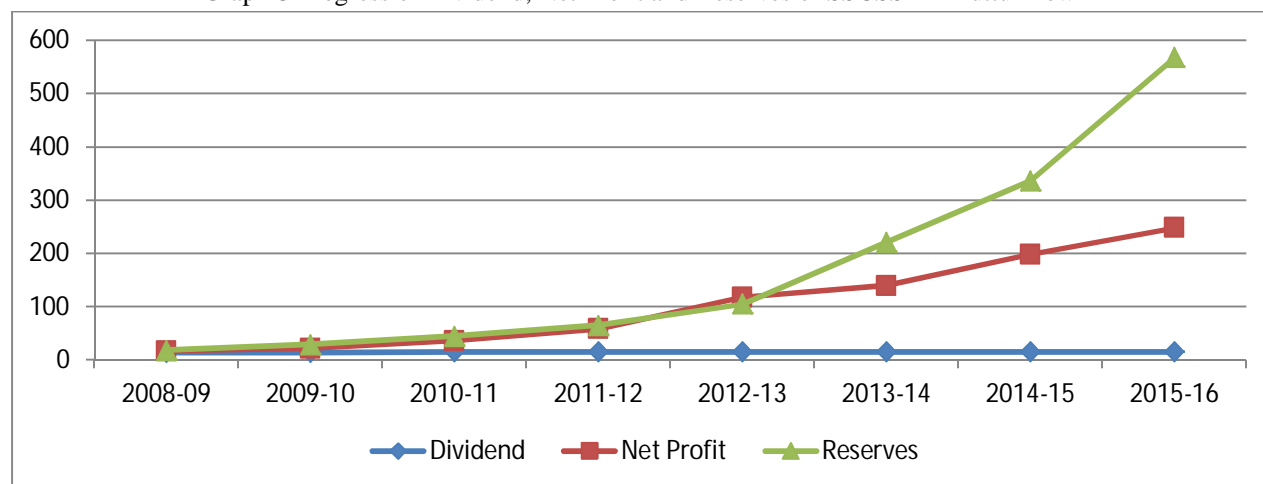
